

# ROODEBERG – FAMILY OF WINE

“KWV Roodeberg” A brand under Warshay Investments (Pty) Ltd T/A KWV

## TERMS & CONDITIONS

1. The promoters are “KWV Roodeberg Wine” (A brand under Warshay Investments Pty (Ltd) Reg no 2012/018 792/07 ta KWV)
2. This promotional competition is open to all South African residents within the borders of South Africa, who are 18 years or older at the date of entry, in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoters, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. This promotional competition commences on 20 April 2022 and ends on 15 June 2022. Any entries received after the closing date will not be considered.
4. To enter, participants will be required to:
  - a. Purchase a bottle or glass of your favourite Roodeberg wine from the participating restaurants and stand a chance to Win a Family of Wine
  - b. To enter scan the QR code on the POS, complete all the fields of the entry form and upload an image of yourself enjoying your favourite Roodeberg wine.
5. The winner must produce proof of identification to claim their prize.
6. Participants enter as many times as they wish provided that each entry is associated with a unique image.
7. 50 x Participating restaurants.
8. The prize made up of : 1x5L , 1x3L, 1x1.5L, 1x750ml Roodeberg Red Blend which makes up a single set.

10. 1 x set as per displayed in the store to be won per store = 1 winner per store
